#### CALL TO ORDER

Chairman, Lowell Barto, called the meeting to order at 5:30 p.m.

### APPROVAL OF MINUTES

Clark made a motion to approve the October 24, 2023, Board of Trustees minutes, November 17, 2023 Special Board of Trustees minutes, October 18, 2023, Finance Committee minutes and September 27, 2023, Medical Staff Integration Committee minutes as presented. Haney seconded the motion and Duncan, Barto, Buchanan, Haney, Joyce, Green and Clark voted in favor of the motion.

### **BOARD EDUCATION: CYBER SECURITY**

CIO, Chris Roark, shared a cyber security update with the members. He noted the surge in attacks to healthcare organizations rising to 66% being attacked in 2021. The average cost to recover from a healthcare data breach is \$10M. Stillwater Medical has a cyber security team as well as third party vendors who work diligently to prevent attacks.

# ACCEPTANCE OF REPORTS FROM OFFICERS OCTOBER 2023 FINANCIAL REPORT/NOVEMBER FINANCE COMMITTEE REPORT

Lovelace provided a PowerPoint summary of operations for October 2023. Admissions, including rehab, were 382 below budget of 406, and last year of 396. Average Daily Census, including rehab was 48, compared to a budget of 49 and last year of 51.

Surgeries were 443 for the month, above last year of 402. Surgeries at the Surgery Center West were 521, below a budget of 651 and last year of 659.

Emergency room visits were 2,931 above budget of 2,503 and last year of 2,521. Outpatient visits, not including ER visits, were 13,701 above budget of 12,365 and below last year of 14,308. Births were 56 for the month.

Financial assistance was \$2.2M for the month. Salaries and Wages were at \$11.7M, below budget of \$11.9M. FTE's were 1,506 below last year of 1,582. Benefits were \$3.2M above last year of \$2.3M.

Operating Income Consolidated is \$93,000, below last year of \$363,000. Operating Income for the Hospitals is \$693,000 below budget and last year of \$1.1M. Operating Income for Stillwater Medical is \$572,000, below budget of \$983,000 and last year of \$1.0M. Operating Income for Stillwater Medical Perry is \$116,000 above last year of \$25,000. Operating Income for Stillwater Medical Blackwell is \$5,000, above last year of (\$111,000). Operating Income for the Clinics is (\$601,000) compared to a budget of (\$157,000) and last year of (\$597,000).

Operating Income for the Hospitals year to date is \$11.3M compared to last year of (\$4,000). Operating Income for the Clinics year to date is (\$8.2M) compared to last year of (\$6.1). Operating Margin for the Hospitals is 5.87% compared to a budget of 4.18%. Operating Margin for the Clinics is -9.7% compared to a budget of -5.6% and last year -7.5%.

YTD Operating Margin Consolidated is 1.09%, compared to a budget of 0.84% and last year of -2.27%. YTD Non-Operating Revenue is \$2.8M, above budget of \$162,000 and last year at (\$17.6M). YTD Net Income Consolidated is \$5.9M, above budget of \$3.3M and last year of (\$23.7M).

The BancFirst investment account decreased to \$86.8M, y-t-d is 2.48%. The Arvest investment account decreased to \$8.4M, y-t-d is 2.37%. The Commerce investment account decreased to \$13.8M, y-t-d is 2.18%. Consolidated Investments for October is \$109.2M.

Days in Accounts Receivable is 37 days. Days Cash on Hand is 149 days. Cash on hand is \$122.1M compared to \$140M at year end 2022. A YTD Operating Income Summary vs Budget was provided, showing a positive Operating Income of \$92,952.

Lovelace shared that the Finance Committee reviewed the financials and summary of clinic operations. BancFirst presented SMC's investment portfolio update. The Committee recommended the Board approve the purchase of the c-arms.

#### NOVEMBER FACILITIES COMMITTEE REPORT

Steven Taylor shared the November Facilities Committee report with the members. He shared that the first baby was delivered in the new area of MCHU yesterday. He noted the completion of the Kitchen Hood System project and the Surgery Center West project.

# OCTOBER MEDICAL STAFF INTEGRATION COMMITTEE REPORT

Joe Ogle shared the October Medical Staff Integration Committee report. He noted that Dr. Breana Smith and Jason Freeling, CRNA started in November. Two ENTs physicians and a GI physician visited.

Buchanan made a motion to accept the October 2023 Financial Report, November Finance Committee Report, October Medical Staff Integration Committee report and November Facilities Committee report. Duncan seconded the motion, and Haney, Joyce, Clark, Duncan, Buchanan, Barto and Green voted in favor of the motion.

# NOMINATING COMMITTEE

Chairman Barto shared that three of our Board members' terms will expire in January. Chairman Barto appointed Mayor Joyce to serve on the nominating committee as representative of the City of Stillwater and Dan Duncan to serve as representative of the Stillwater Medical Board to make recommendations to the Stillwater City Council.

#### APPROVAL OF PURCHASE OF C-ARMS

Greg Stackenwalt shared that the C-Arms are used in surgery and provide real-time imaging during surgical procedures. The current equipment is over 20 years old, making it difficult to service. The new equipment offers higher resolution, lower radiation dose exposure and faster imaging time. Three bids were received: GE, \$365,331; Philips, \$287,053.20; and Siemens, \$290,708. Philips is the lowest bid and bid of choice by staff.

Clark made a motion to approve the purchase of two Philips C-Arms at a total cost of \$287,053.20. Haney seconded the motion and Duncan, Buchanan, Clark, Barto, Green, Joyce and Haney voted in favor of the motion.

# CONSENT AGENDA

Dr. Matthew Payne updated the Board members on the Consent Agenda items for Stillwater Medical Health System and Stillwater Medical Center. All actions listed on the consent agenda were approved through our Medical Staff Committees.

Haney moved the Board approve the Consent Agenda for Stillwater Medical Health System and Stillwater Medical Center. Duncan seconded the motion and Joyce, Buchanan, Clark, Green, Barto, Duncan and Haney voted in favor of the motion.

Steven Taylor updated the Board members on the Consent Agenda items for Stillwater Medical Perry and Stillwater Medical Blackwell. All actions listed on the consent agenda were approved through our Medical Staff Committees.

Joyce moved the Board approve Consent Agenda items for Stillwater Medical Perry and Stillwater Medical Blackwell. Haney seconded the motion and Buchanan, Haney, Joyce, Green, Duncan, Barto and Clark voted in favor of the motion.
