CALL TO ORDER

Chairman, Lowell Barto, called the meeting to order at 5:33 p.m.

APPROVAL OF MINUTES

Buchanan made a motion to approve the September 26, 2023, Board of Trustees minutes, September 20, 2023, Finance Committee minutes and September 12, 2023, Facilities Committee minutes as presented. Haney seconded the motion and Duncan, Barto, Buchanan, Haney, Green and Clark voted in favor of the motion.

BOARD EDUCATION: VIZIENT CEO TRUSTEE EDUCATION SESSION HIGHLIGHTS

Denise Webber shared an overview of the education shared at the Vizient CEO Trustee Conference. She shared the State of the Industry, data and anticipated changes in healthcare. Labor and workforce challenges are being felt nationally. The presenters believe that artificial intelligence (AI) will likely takeover redundant tasks. Their recommendations for success included a strong balance sheet, knowing what patients want and being a high-reliable organization.

STRATEGIC PERFORMANCE SCORECARD

Webber shared current scores in each category with the members. Inpatient, Quality and Growth scores remain at 4-star. She shared that our team is working on initiatives to be discussed at the upcoming Board Retreat.

ACCEPTANCE OF REPORTS FROM OFFICERS SEPTEMBER 2023 FINANCIAL REPORT/OCTOBER FINANCE COMMITTEE REPORT

Lovelace provided a PowerPoint handout of the summary of operations for September 2023. Admissions, including rehab, were 388 below budget of 406, and above last year of 371. Average Daily Census, including rehab was 47, compared to a budget of 49 and last year of 49.

Surgeries were 425 for the month, above last year of 406. Surgeries at the Surgery Center West were 598 for the month, above last year of 577.

Emergency room visits were 2,925 above budget of 2,312 and last year of 2,673. Outpatient visits, not including ER visits, were 12,556 above budget of 12,365 and below last year of 12,800. Births were 56 for the month, compared to a budget of 67 and last year at 63.

Financial assistance was \$329,000 for the month. Salaries and Wages were at \$10.7M, below last year of \$10.99M. FTE's were 1,490 below last year of 1,580. Benefits were \$2.47M below last year of \$2.48M.

Operating Income Consolidated is (\$65,000), below last year of (\$37,000). Operating Income for the Hospitals is \$923,000, above last year of \$771,000. Operating Income for Stillwater Medical is \$833,000, below last year of \$861,000. Operating Income for Stillwater Medical Perry is \$44,000, above last year of (\$69,000). Operating Income for Stillwater Medical Blackwell is \$47,000, above last year of (\$21,000). The Rural Emergency Hospital payment of \$528,000 was received for Perry and Blackwell. Operating Income for the Clinics is (\$988,000) compared to last year of (\$809,000).

Operating Income for the Hospitals year to date is \$10.6M compared to a budget of \$7.2M and last year of (\$963,000). Operating Income for the Clinics year to date is (\$7.6M) compared to last year of (\$3.1M). Operating Margin for the Hospitals is 6.2% compared to last year of -.55%. Operating Margin for the Clinics is -10% compared to last year -7.5%.

YTD Operating Margin Consolidated is 1.19%, compared to a budget of 0.84% and last year of -2.67%. YTD Non-Operating Revenue is \$5.6M, above last year at (\$21.2). YTD Net Income Consolidated is \$8.5M, above last year of (\$27.M).

The BancFirst investment account decreased to \$89.0M and year to date is 4.47%. The Arvest investment account decreased to \$8.6M and year to date is 2.32%. The Commerce investment account decreased to \$14.1M and year to date is 5.04%. Consolidated Investments for August is \$111.9M.

Days in Accounts Receivable is 39 days. Days Cash on Hand is 154 days. Cash on hand is \$125.9M compared to \$140M at year end 2022.

A YTD Operating Income Summary vs Budget was provided.

Lovelace shared that the Finance Committee reviewed the financials and summary of clinic operations. Arvest presented SMC's investment portfolio update.

SEPTEMBER MEDICAL STAFF INTEGRATION COMMITTEE REPORT

Joe Ogle shared the September Medical Staff Integration Committee report. He noted that a signed letter of intent was received from the child psychiatrist approved at last month's Board meeting. An ENT, pulmonologist and medical oncologist have each visited recently.

Clark made a motion to accept the September 2023 Financial Report, October Finance Committee Report and September Medical Staff Integration Committee report. Duncan seconded the motion, and Haney, Clark, Duncan, Buchanan, Barto and Green voted in favor of the motion.

APPROVAL OF ADMINISTRATIVE POLICIES

Webber shared the new Administrative Policy and Procedure Development policy and recommended changes to the Uninsured policy.

Haney made a motion to approve the Administrative Policies as presented. Clark seconded the motion, and Duncan, Buchanan, Clark, Barto, Green and Haney voted in favor of the motion.

APPROVAL OF 2024 SCHEDULE OF REGULAR MEETING DATES

The members reviewed the suggested 2024 calendar of regular meeting dates. The members discussed moving the November meeting date to November 21 2024 and the December meeting date to December 19, 2024 due to the holidays.

Haney made a motion to approve the suggested 2024 schedule of regular meeting dates. Clark seconded the motion and Clark, Duncan, Green, Barto, Haney and Buchanan voted in favor of the motion.

CONSENT AGENDA

Dr. Matthew Payne updated the Board members on the Consent Agenda items for Stillwater Medical Health System and Stillwater Medical Center. Webber shared that the "Expedited Credentialing" policy would allow expedited approval of clean applications with no concerns, later coming back through the Committees and Board. Gary Clark recommended amending this policy to include under #4 "or, in the opinion of the CEO there is an urgent need, the CEO may act on behalf of the entire Board of Trustees."

Clark moved the Board approve the Expedited Credentialing policy inclusive of the amendment under #4 "or, in the opinion of the CEO there is an urgent need, the CEO may act on behalf of the entire Board of Trustees."

Duncan seconded the motion and Green, Clark, Buchanan, Haney, Duncan, and Barto voted in favor of the motion.

Duncan moved the Board approve all other policies and credentialing actions on the Consent Agenda for Stillwater Medical Health System and Stillwater Medical Center. Haney seconded the motion and Buchanan, Clark, Green Barto, Duncan and Haney voted in favor of the motion.

Steven Taylor updated the Board members on the Consent Agenda items for Stillwater Medical Perry and Stillwater Medical Blackwell. All actions listed on the consent agenda were approved through our Medical Staff Committees. Webber share that REH policies must be approved every two years instead of our standard three years.

Clark moved the Board approve Consent Agenda items for Stillwater Medical Perry and Stillwater Medical Blackwell. Buchanan seconded the motion and Buchanan, Haney, Green, Duncan, Barto and Clark voted in favor of the motion.
